Spotlight 1: January Why India Wishes to Destabilize Pakistan?

In a conflict ridden history of India and Pakistan relations, Pakistan for the first time has shared a dossier on Indian involvement in destabilizing Pakistan. The dossier contains evidence of Indian involvement in terrorist activities within Pakistan. It also alleges the Indian government of financially sponsoring terrorist activities in Pakistan. According to the dossier, India paid 820,000 dollars to the leadership of Tehrik e Taliban Pakistan. It is running 87 training camps out of which 66 are located in Afghanistan and 21 are located in India. With the dossier, the government of Pakistan wanted to convey to the world that India is actively involved in creating unrest in the country. And it also aims at jeopardizing China's project of China Pak Economic Corridor.

Spotlight 2: February Recklessness, War Crimes and the case of Afghanistan

The recent news of the Australian troops perpetrating alleged war crimes on civilians and combatants within Afghanistan sparked a major outrage and uproar all over the world. Australia has been part of the of the US-led military coalition in Afghanistan since 2001. It is also a state party to the Rome Statute since 2002. As such, it is bound by the International Humanitarian Law (IHL). The principle of complementarity in Article 17 of the Rome Statute specifies that the International Criminal Court (ICC) "will only exercise its jurisdiction if a State fails to genuinely investigate and prosecute a situation in which crimes against international humanitarian law have been committed." Essentially, it implies that until and unless Australia is unable or unwilling to prosecute, the jurisdiction remains with the state in question.

Spotlight 3: March The quandary of SAARC in the backdrop of COVID-19)

With the spike of Covid-19 cases in March 2020, Indian Prime Minister Narendra Modi called the summit of South Asian Association for Regional Cooperation (SAARC) countries to formulate a joint strategy to address "disease surveillance data in real time" to curb the spread of pandemic. The call for the summit was warmly received by all the member states. The Summit was held virtually on March 15, 2020 keeping into consideration the ongoing Covid-19 pandemic. In the summit, all countries were represented by their heads of the governments except Pakistan. Pakistan deputed Dr. Zafar Mirza, de-facto health Minister for this meeting.



Kashmir's Self Determination Day

The Institute of Regional Studies held an in-house Roundtable on 5th January on the occasion of Kashmir self-determination day. The event was moderated by Amna Nisar Abbasi, Asst. Research Officer. In her opening remarks, Ms. Abbasi stated that right of self-determination is an essential component of human dignity and its negation is actually a denial of basic human rights. The deteriorating human right situation in Kashmir followed by Indian unilateral revocation of special status on 5th August 2019, has necessitated immediate global intervention to implement UN resolution in its true spirit.

February 03, 2021

He was speaking at a seminar titled 'Standing with the Unheard Voices of Kashmir' organized by the Institute of Regional Studies (IRS). He condemned the Indian action of issuance of over 1.8 million domicile certificates to non-residents of IIOJK under the watch of around one million-strong Indian forces stationed in the territory. He was of the view that the move was aimed at changing the demography of Kashmir. He added that India faced international censure for its August 2019 actions and called for greater focus on exposing Indian atrocities in Kashmir by engaging not only foreign governments but also foreign parliaments and think-tanks.

Cyber Threats and Pakistan's Response

March 30, 2021

Cybersecurity experts have warned that ungoverned rapid digitization in the country is a threat to important government and private organizations. Speaking at the IRS webinar, the experts urged that the heavy reliance on the imported hardware on the other hand is increasingly compromising the security of sensitive information since Pakistan is lagging in the field of manufacturing IT types of equipment. They also called for the inclusion of cybersecurity subjects in textbooks for a better understanding of the data threats. The panel of experts included Sehrish Mujtaba, a leading cybersecurity professional, Mr. Arzak Khan, internet governance and cybersecurity expert, and Umar Sheraz, the futurist, innovative policy analyst.




